COURSE DESCRIPTIONS

1st SEMESTER

ADL101 Basic Law

The relationship between social law codes and legal rules, sources of law, law branches, public law, the separation of private law, application of legal rules, concept of rights, types of rights, acquisition of rights, loss, protection, debt concept, debt relations, personality concept, protection, judicial organization and types of cases.

ADL103 Constitutional Law

In this course, general principles and basic concepts of constitutional law are explained. The subject of the course is the constitution, the making and changing of the constitution. Constitutional state and constitutional movements, legislative-executive judicial affixes, political regimes (government systems), parliamentary government regime, presidential regime, parliamentary regime, political parties, democracy, elections, electoral systems, fundamental rights and freedoms, and so on issues.

ADL105 Civil Law

The initial provisions of the Civil Code include real and legal persons, engagement, marriage, divorce, poverty and the attachment to the association, lineage, adoption, custody and tutelage.

ADL207 Equity Legislation And Judicial Correspondence
